NRA Outdoor 2700 Pistol Match

DATES: All league matches will be held on the fourth Saturday.

Dates for 2018 are: 27-Jan, 24-Feb, 24-Mar, 28-Apr, 23-June, 25-Aug, 22-Sep, 27-Oct, 24-Nov.
No league matches will be held in the months of May (NRA Regional Match), July, or Dec.

LOCATION OF RANGE:

Pensacola Rifle & Pistol Club:

Pensacola Rifle and Pistol Club is 20 minutes north of Pensacola, FL. Proceed north from Pensacola on US 29 (I-10 has a full access interchange with US 29) through Cantonment, FL then 4.3 miles beyond the second traffic light. Turn left on Matheson Road, which is directly opposite the Escambia County Clinic building. Proceed west to the end of Matheson Road, turn left and continue south to the front gate of the range which will be open the day of the match. Enter and proceed to the pistol range which is located in the middle of the long covered firing line. DO NOT use a GPS device as it will take you the wrong direction. Use the map on the club website www.pensacolarifleandpistolclub.com.

TIMES: Firing will begin at 9:30 am.

RULES: NRA Conventional Pistol Rules will govern and NRA shooter classification system will be used. Unclassified shooters and shooters with no proof of classification will fire in the Master Class. Eye and ear protection is required.

COMPETITION OPEN TO: Any member or non-member of the club, NRA membership is not required. Limited to the first 25 competitors.

FEES: A \$5 NRA league fee will be collected at each shooter's first match.

2700 package is \$10. Individual entry is \$5 per 900 match.

Unclassified and temporarily classified or junior competitors may shoot a .22 in all matches.

Competitors may elect to shoot 900, 1800 or 2700

ECI: Empty Chamber Indicators will be used by all competitors. ECI's will be available for \$1.00 at the match.

AMMUNITION: Competitors must furnish their own safe ammunition.

SIGHTS: Metallic sights or optical sights as permitted under *Rule 3: Equipment and Ammunition*.

SQUADDING: Competitors can be squadded the day of the match or early through response to the email announcement.

TARGETS:

50 yard slow fire Standard American Target (B-6); fixed position target frames.

25 yard rapid or timed fire (B-8); electric turning target frames.

COURSE OF FIRE: NRA 2700 Conventional Pistol Match (.22 / Center Fire / .45)

.22 Caliber Match

- Match #1: .22 Cal Slow Fire, 20 Shots, 50 yards Target B6
- Match #2: .22 Cal National Match Course, 30 shots B6, B8
- Match #3: .22 Cal Timed Fire, 20 shots, 25 yards Target B8
- Match #4: .22 Cal Rapid Fire, 20 shots, 25 yards Target B8
- Match #5: .22 Cal Aggregate of Matches 1, 2, 3, and 4

Center Fire Match

- Match #6: Center Fire Slow Fire, 20 Shots, 50 yards Target B6
- Match #7: Center Fire National Match Course, 30 shots B8, B6
- Match #8: Center Fire Timed Fire, 20 shots, 25 yards Target B8
- Match #9: Center Fire Rapid Fire, 20 shots, 25 yards Target B8
- Match #10: Center Fire Aggregate of Matches 6, 7, 8, and 9

Lunch Break, approximately 30 minutes.

.45 Caliber Match

- Match #11: 45 Cal Slow Fire, 20 Shots, 50 yards Target B6
- Match #12: 45 Cal National Match Course, 30 shots B6, B8
- Match #13: 45 Cal Timed fire, 20 shots, 25 yards Target B8
- Match #14: 45 Cal Rapid fire, 20 shots, 25 yards Target B8
- Match #15: 45 Cal Aggregate of Matches 11,12,13,14
- Match #16: Grand Aggregate of Matches 5, 10, and 15
