CMP Games Match -- M1 Garand, Springfield, Vintage & Modern Military Rifles

DATE: 1 May 2021

LOCATION OF RANGE:

Pensacola Rifle & Pistol Club: 2700 Matheson Rd., Molino, FL 32577

Pensacola Rifle and Pistol Club is located in central Escambia County, FL. Proceed north from Pensacola on US 29 (I-10 has a full access interchange with US 29) through Cantonment, FL for 4.3 miles beyond the second traffic light. Turn left on Matheson Road, which is directly opposite the Escambia County Clinic building. Proceed west to the end of Matheson Road, turn left and continue south to the front gate of the range. The end of the range road is the 200 yard firing line parking area.

COMPETITION OPEN TO: Any eligible competitor, you need not be a member of the NRA, CMP or the sponsoring club. All competitors must have an "Eligibility Affidavit and Liability Agreement" on file at the sponsoring club or present at registration.

TIME: First Relay will begin at 9am. Additional relays will be added as necessary.

RULES: Current edition of CMP Rules. (https://thecmp.org/wp-content/uploads/CMPGamesRules.pdf)

FEES: Each match entry is \$10.00 for adults and \$5.00 for juniors. Competitors are welcome to fire different rifles for each match or fire the same rifle as a re-entry match.

ECI: Empty Chamber Indicators will be used by all competitors. ECI's will be available for \$2.00.

AMMUNITION: Competitors must furnish their own safe ammunition.

RIFLES:

As-Issued M1 Garand (Rule 4.2.2) The rifle must be a Caliber .30 U. S. M1 Garand rifle that was issued by the U.S. Armed Forces and be in as-issued condition. A Caliber .30 M1941 Johnson rifle or a U.S. Carbine Caliber .30 M1 may be fired in matches designated as M1 Garand matches.

As-Issued M1903 Springfield (Rule 4.2.3) The rifle must be a standard issue service rifle that was issued by the U.S. Armed Forces and be in as-issued condition. Permitted rifles are the Caliber .30 U. S. Model 1903 and Model 1903 A3 Springfield rifles, except that Caliber .30 U. S. Model 1903 Springfield rifles manufactured by Springfield Armory with serial numbers of 810,000 or lower or by Rock Island Arsenal with serial numbers of 285,506 or lower may not be used in any CMP-sanctioned competition.

Other As-Issued U. S. Military Rifles (4.2.4) The rifle must be a manually operated rifle that was issued by the U.S. Armed Forces and be in as-issued condition. Permitted rifles are the Caliber .30 U. S. Model 1917 and the Caliber .30-40 U. S. Krag. Other U. S. military rifles such as the Caliber .30-40 M1895 (lever action) and 6mm caliber M1895 Lee-Navy rifle may be used.

As-Issued Foreign Military Rifle (Rule 4.2.5) The rifle must be a rifle that was issued by the Armed Forces of a country other than the U. S. and be in as-issued condition. All as-issued foreign military rifles must be manually operated bolt-action or straight-pull rifles. Semi-automatic or fully automatic rifles are not permitted.

Modern Military Rifles, Class A (Rule 5.2.3) must comply with these requirements: based on the M-16 rifle or be based on an AR design, manufactured by a USA manufacturer; equipped with issue-type metallic front and rear sights.

Modern Military Rifles, Class B (Rule 5.2.4) must comply with these additional requirements: manufactured in the U. S. or another country may be used; equipped with standard issue-type metallic front and rear sights; chambered for any cartridge not exceeding caliber 8 mm.

Unlimited Modern Military Rifles (Rule 5.2.5(b)) may have optical sights (reflective sights are considered optical sights) with a maximum magnification of 4.5X installed on the receiver. Variable scopes with a maximum magnification of 4.5X are permitted. Only commercially manufactured scopes that were produced with a maximum magnification of 4.5X and have a maximum objective lens diameter of 34 mm may be used. **Unlimited M1 Garand** (Rule 5.2.6) must have an M1 Garand external configuration, weigh no more than 10.5 lbs. and have a trigger pull of at least 4.5 lbs. Unlimited M1 Garands include National Match M1 Garands with synthetic bedding and/or NM sights; M1 Garands modified to fire the 7.62 mm NATO cartridge;

SQUADDING: Competitors can get on the list by sending an email to prpc.competitions@gmail.com. A sign up will be sent on the Monday before the match when squadding opens. Firing point and relay reservations can be made by replying to the message. There are a maximum 12 firing points per relay.

COURSE OF FIRE: As-Issued Military Rifle Course A, 30 shots, 200 yards.

Sighting Stage: 5 rounds slow fire in any firing position, 5 minutes.

10 Rounds slow fire from a prone position, 10 minutes.

1 Strings of 10 shots rapid fire from standing to prone position, 80 seconds.

10 Rounds slow fire from a standing position, 10 minutes.

TARGETS: SR5, 200 yards scoring to 7 ring, hits on paper outside the 7 ring scored as a 6. No target pits, targets scored after each stage.

AWARDS: Gold, silver and bronze CMP award pins for those who equal or exceed the CMP achievement award cut scores established in the CMP rulebook. Scores will be reported to CMP.

AFFIDAVIT AND LIABILITY AGREEMENT INFORMATION

To assist in explaining the affidavit requirement for participation in Civilian Marksmanship Program events, the following information is provided.

Congress in Public Law 104-106 enacted in February 1996 imposed the affidavit equipment. This legislation allowed the Civilian Marksmanship Program to continue by transferring it from the Army to a new private entity created by Congress called the Corporation for Promotion of Rifle Practice and Firearms Safety, Inc.

Section 40723 title 36 United States Code provides:

- (1) Before a person may participate in any activity sponsored or supported by the Corporation, the person shall be required to certify by affidavit the following:
 - A) The person has not been convicted of any Federal or State felony or violation of section 922 of title 18.
 - B) The person is not a member of any organization that advocates the violent overthrow of the United States Government.

By definition an affidavit is a statement that is sworn before an official authorized to administer an oath, for example, a notary public. That in brief, is the reason for this procedure. Unless and until the law is changed, we have to comply with it.

There are some steps you can take to minimize the inconvenience. First, each person needs to make the affidavit only ONCE (not at every event). The affidavit need not be completed at the event, but can be done well in advance. For example, the club could distribute the affidavit form to all its members with its next regular mailing, thus cover all of its own members. Event announcements could include a notice that any non-members desiring to participate bring with them a completed affidavit. This affidavit is required only for participants' 18 years of age and older.

Further, there is no requirement to send these affidavits to the CMP. They are to be retained by the club. The club officers simply certify in their annual reports to the CMP that the club requires such affidavits for all participants, and that they are kept on file. The only affidavits that the CMP itself will keep are those we require annually, at the National Trophy Matches.

It should be pointed out that the affidavit has at least one redeeming feature. You will note that the form provided by the CMP has two parts. The first part is the certification required by law, discussed above; the second part is a waiver of liability. This protects the club sponsoring the event as well as the CMP against any claim caused by the carelessness of others. Lawsuits against anyone with the remotest connection to a mishap are an unfortunate fact these days. This can be financially ruinous to many clubs that do not have the resources to fight frivolous claims. The fact that the waiver of liability is included within a document that is notarized reinforces its validity.

 suffer in connection with the activity, and
 - 3. Defend, indemnify and hold harmless any organization sponsoring or supporting the activity from any claim of a third party arising from any negligent or wrongful conduct by me.
